Welcome Message from desk of Dean














Visit to National Company Law Tribunal (NCLT)





Student Reflections

"THE INDIAN REBELLION OF 1857: A DEFINING CHAPTER IN THE STRUGGLE AGAINST BRITISH RULE"

The Indian Rebellion of 1857, spanning from 1857 to 1859, was widespread yet ultimately uprising unsuccessful against British colonial rule. It began in Meerut, initiated by Indian troops serving under the British East India Company, and swiftly spread to Delhi, Agra, Lucknow, becoming a powerful symbol of the nation's resistance



to colonial exploitation. While Western historians referred to it as the "Indian Mutiny" or "Sepoy Mutiny," in India, it is celebrated as the First War of Independence.

The rebellion was sparked when Mangal Pandey, a young soldier, was executed in Barrackpore for attacking his officers. Shortly after, the sepoys of Meerut's regiment refused to drill with newly introduced cartridges believed to be greased with cow and pig fat—a direct affront to the religious beliefs of Hindu and Muslim soldiers. In response to their refusal, 85 soldiers were dismissed and sentenced to 10 years in prison. Outraged, their fellow sepoys stormed the jail, freed the prisoners, and attacked British officers, capturing weapons and setting British properties ablaze. Their ultimate aim was to overthrow British rule and install Mughal Emperor Bahadur Shah Zafar as their leader.

Student Reflections

The rebellion quickly gained momentum, spreading like wildfire. Soldiers were joined by townspeople, villagers, zamindars, and local chiefs, united in their determination to reclaim authority. The oppressive taxation policies, rigid revenue collection systems, and exploitation of peasants and zamindars further fueled the discontent.

The Indian ruling class also felt the brunt of British strategies to consolidate power. The Doctrine of Lapse, introduced by Lord Dalhousie, allowed the British to annex princely states without a biological heir, leading to the loss of sovereignty for many rulers, such as Nana Sahib. Similarly, subsidiary alliances imposed by the British served to erode the independence of princely states.

Although the Indian Rebellion of 1857 failed to overthrow British rule, it marked the beginning of a prolonged struggle for India's independence. The rebellion demonstrated the courage and unity of diverse communities and set the stage for the rise of Indian nationalism. Its legacy remains a reminder of the sacrifices made by countless individuals in the fight for freedom and continues to inspire generations to safeguard the hard-earned independence of the nation.
