

MEMORANDUM OF UNDERSTANDING

BETWEEN

UNIVERSITY OF ENGINEERING AND MANAGEMENT, JAIPUR

AND

UNIVERSITY OF ENGINEERING AND MANAGEMENT, KOLKATA

This Memorandum of Understanding (this “MOU”) is entered into by the University of Engineering and Management, Kolkata (herein after "UEM Kolkata") and University of Engineering and Management, Jaipur (herein after "UEM Jaipur").

The Parties hereinabove desire to engage and collaborate in activities including academic, scientific and cultural broadly under the following objectives, actions, duration, etc:

I. OBJECTIVES

University of Engineering and Management Jaipur and University of Engineering and Management, Kolkata desire to collaborate and develop various academic and research programs, as well as to promote collaborative and joint projects in the mutually agreed areas. The participation of the institutions in any of such specific programs shall be subject to the availability of adequate funds.

II. ACTIONS

A. Actions that may be carried out under this MOU include:

1. Joint research activities;
2. Faculty Exchange program;
3. Student Exchange program;
4. Information Exchange in the fields of mutual interest to faculty and

students of the two institutes.

5. Faculty, Researcher and staff exchange for lectures, talks, symposiums, conversations and sharing of experiences. The parties will develop working programs for specific projects to define the duties and responsibilities of each party independent of this MOU.

B. The parties hereby agree to adhere to the following conditions:

1. Any exchange of students or faculty or staff shall be in strict conformance with the rules, regulations and policies established by each organization.

2. The parties will each appoint one responsible person for the supervision and successful completion of the programs / events to be developed under this MOU.

3. For each program to be developed under this MOU, the financial responsibility of each party will have to be agree upon independently. Such financing will be subject to the rules, regulations and policies of each organization.

4. Both organizations agree that the personnel provided by each organization for the implementation of the work programs developed under this MOU will be affiliated exclusively with his/her employer and that each organization will assume their responsibilities to this end, and in no case will either organization be liable for any act of the other.

5. The production, publication and distribution of articles, pamphlets and other works generated from such work programs under this MOU will be undertaken by mutual agreement and will be jointly owned by the parties. The parties hereby agree to seek maximum protection under Intellectual property available for protecting each publication, discovery or inventions. It is understood that each party may use the results obtained from the collaborative and joint activities completed under this MOU for academic and other purposes. It is expressly agreed that any unauthorized commercial use of a joint work product by either party will result in the disgorgement of profits to that party resulting from such unauthorized use.

6. Authorship of any written work will be attributed to the party whose personnel produced the work with recognition being given to the individuals who contributed to the work. If the work is produced by personnel from both parties, authorship will be attributed to both organizations equally.

III. DURATION, MODIFICATIONS AND TERMINATION

This MOU will be in effect for three (3) years, starting on the date the last party signs this MOU. This terms and conditions of this MOU can be modified or the term be extended only by a written amendments executed by both parties. The modifications or extensions will be effective from the date the said amendment is executed by both the parties. This MOU may be terminated for any reason by either party by giving to the other thirty (30) days written notice prior to such termination.

IV. DISPUTE RESOLUTION

This MOU is entered into by the parties in good faith and in furtherance of academic objectives. The parties will explore all avenues to resolve any conflict or dispute which may arise with regard to the interpretation and enforcement of this MOU. Any disputes or conflicts which cannot be resolved at the appropriate operational levels shall be referred to the presidents of each organization for final resolution.

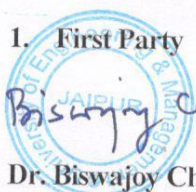
V. ASSIGNMENT
