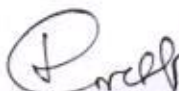

WHEREAS:

- A) First Party is a Higher Educational Institution named: **UNIVERSITY OF ENGINEERING AND MANAGEMENT JAIPUR (UEM Jaipur)**
- B) First Party & Second Party believe that collaboration and co-operation between themselves will promote more effective use of each of their resources and provide each of them with enhanced opportunities.
- C) The Parties intend to cooperate and focus their efforts on cooperation within the area of Skill Based Training, Education and Research.

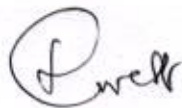

- D) Both Parties recognize the importance of academic-industry collaboration in research, innovation, community outreach, skill development, and capacity building for mutual benefit and societal impact.
- E) Both Parties, being legal entities in themselves desire to sign this MOU for advancing their mutual interest.
- F) **The Second Party, Bhagwan Mahaveer Viklang Sahayata Samiti (BMVSS - Jaipur Foot)**, is engaged in humanitarian service, skill development, manufacturing, education, and research & development activities in the fields of prosthetics, orthotics, assistive technology, rehabilitation sciences, and community-based rehabilitation services, along with related healthcare and social welfare fields.
- G) **The First Party, University of Engineering and Management Jaipur (UEM Jaipur)** is engaged in higher education, training, skill development, research & development, and consultancy in the fields of engineering, physiotherapy, biomedical sciences, management, and allied disciplines, and is committed to promoting innovation and social impact through academia-industry collaborations.
- H) The Second Party, Bhagwan Mahaveer Viklang Sahayata Samiti (BMVSS - Jaipur Foot), headquartered in Jaipur, Rajasthan, is the world's largest organization for the rehabilitation of persons with disabilities. It has several national and international branches/centers and operates outreach programs in India and abroad. BMVSS provides free-of-cost prosthetic limbs, calipers, crutches, wheelchairs, and other aids to people with disabilities. The organization has a multidimensional role encompassing manufacturing of assistive devices, community service, education, training, research and development, as well as international collaborations, thereby making significant contributions in the field of disability rehabilitation and social welfare.

**NOW THEREFORE, IN CONSIDERATION OF THE MUTUAL PROMISES SET FORTH
IN THIS MOU, THE PARTIES HERETO AGREE AS FOLLOWS:**

CLAUSE 1 CO-OPERATION

- 1.1. Both Parties are united by common interests and objectives and agree to establish effective channels of communication and co-operation to promote and advance their respective missions within the Institution and its associated wings. The Parties shall keep each other informed of potential collaborative opportunities and shall share information relevant for securing additional academic, research, training, and community engagement initiatives.
- 1.2. Co-operation between the First Party and the Second Party will facilitate the effective utilization of the intellectual capabilities, resources, and expertise of the faculty and students of the First Party, while providing significant inputs from the Second Party to develop suitable teaching, training, and skill development systems in line with the needs of industry and society.
- 1.3. The general framework of co-operation shall be governed by this MoU. The Parties shall, as promptly as reasonably practical, enter into all relevant agreements, deeds, or documents (the 'Definitive Documents') that may be required to give effect to specific actions contemplated under this MoU. The terms of such Definitive Documents shall be mutually decided between the Parties. This MoU, along with the Definitive Documents, shall represent the entire understanding between the Parties on the subject matter and shall supersede any prior arrangements, discussions, or understandings related to the same.

CLAUSE 2 SCOPE OF THE MoU

2.1 The budding graduates from the Institution (First Party) could play a key role in technological up-gradation, innovation, rehabilitation research, and service delivery in collaboration with the

Second Party. Both Parties believe that close co-operation will benefit the student community by enhancing their academic knowledge, practical skills, and professional competence.

2.2 Curriculum Design & Knowledge Sharing: The Second Party will provide valuable inputs to the First Party in teaching, training methodologies, and applied research. These inputs will help customize the curriculum and learning modules so that students are better equipped to contribute meaningfully in the fields of prosthetics, orthotics, assistive technology, rehabilitation sciences, and community-based healthcare.

2.3 Training, Exposure & Visits: The collaboration between the First Party and Second Party will provide faculty and students with exposure to real-world practices and innovations in disability rehabilitation and assistive technologies. The Second Party shall permit students and faculty of the First Party to visit its facilities, participate in training programs, and gain hands-on experience in labs, workshops, and rehabilitation camps. This practical exposure will build confidence and prepare the students for a smooth transition from academic learning to professional service and research careers.

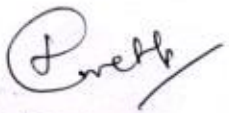
2.4 Internships and Placement of Students: The Second Party will actively support the First Party in providing internship and placement opportunities for its students.

2.5 Research and Development: Both Parties agree to undertake joint research and development activities in the fields of prosthetics, orthotics, assistive devices, rehabilitation sciences, biomedical engineering, physiotherapy, and related healthcare technologies. Collaborative R&D may include prototype development, field trials, technology transfer, and community-based projects.

2.6 Skill Development Programs: The Second Party shall provide training and skill development opportunities to the students of the First Party in emerging technologies and practices in disability rehabilitation. Such programs will aim to bridge the skill gap, enhance employability, and prepare students to become industry- and society-ready professionals.

2.7 Guest Lectures: The Second Party shall extend support by delivering guest lectures, expert talks, and special sessions to the students of the First Party on technology trends, innovative practices, rehabilitation methods, and organizational requirements.

2.8 Faculty Development Programs (FDPs): The Second Party shall support the training of faculty members of the First Party by providing industrial exposure, orientation, and hands-on

workshops. The FDPs shall be designed in alignment with the National Occupational Standards (NOS), wherever applicable, to ensure best practices in teaching and training.

2.9 Approvals and Compliance: Both Parties shall obtain all necessary internal approvals, consents, permissions, and licenses required for offering programs, training, and other initiatives under this MoU, in accordance with applicable policies and regulations.

2.10 Financial Clause: There shall be no financial commitment on the part of the Institute of Engineering and Management Jaipur (IEM Jaipur) of University of Engineering and Management Jaipur (UEM Jaipur), the First Party, for undertaking any program under this MoU. If any program requires financial consideration, the terms shall be discussed separately and formalized through a mutually agreed arrangement.

CLAUSE 3 INTELLECTUAL PROPERTY

3.1 Nothing contained in this MoU shall, whether by express grant, implication, estoppel, or otherwise, be construed as conferring upon either Party any right, title, interest, or license in or to the intellectual property (including but not limited to know-how, inventions, patents, copyrights, designs, trademarks, trade secrets, or any other proprietary information) owned or developed independently by the other Party.

3.2 Intellectual property arising out of any joint research, development, or collaborative activity undertaken pursuant to this MoU shall be governed by specific agreements to be executed separately between the Parties, clearly defining the ownership, rights of use, protection, and commercialization of such intellectual property.

3.3 Both Parties agree to respect and protect each other's intellectual property rights and shall not, without prior written consent, use the name, logo, or other proprietary marks of the other Party in any publication, document, or publicity material.

CLAUSE 4 VALIDITY

4.1 This MoU shall remain valid until expressly terminated by either Party on mutually agreed terms. During this period, the Second Party, Bhagwan Mahaveer Viklang Sahayata Samiti (BMVSS - Jaipur Foot), shall take effective steps for the implementation of the provisions of this MoU. Any act on the part of the Second Party after the termination of this MoU, including communication or correspondence, shall not be construed as an extension or renewal of this MoU unless agreed in writing by both Parties.

4.2 Either Party may terminate this MoU by giving thirty (30) calendar days' prior written notice to the other Party. In the event of termination, both Parties shall ensure that they duly discharge their respective obligations already undertaken prior to the effective date of termination.

CLAUSE 5 RELATIONSHIP BETWEEN THE PARTIES

5.1 It is expressly agreed that the First Party and the Second Party are acting under this MoU as independent entities, and nothing contained herein shall be construed to create a partnership, joint venture, agency, or employer-employee relationship between them.

5.2 Neither Party shall use the name, logo, or identity of the other Party in any manner, nor make any representations, commitments, obligations, or liabilities, whether expressed or implied, on behalf of the other Party, without prior written consent.

5.3 Neither Party shall have, nor represent itself as having, any authority under this MoU to enter into agreements, contracts, or arrangements of any kind in the name of, or binding upon, the other Party; nor shall either Party pledge or extend credit on behalf of the other Party.

Any divergence or difference derived from the interpretation or application of the MoU shall be resolved by arbitration between the parties as per the Arbitration Act, 1996. The place of the arbitration shall be at District Head Quarters of the First Party. This undertaking is to be construed in accordance with Indian Law with exclusive jurisdiction in the Courts of **JAIPUR (RAJASTHAN)**.

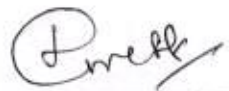

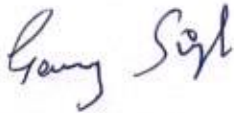

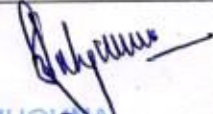
