External members suggested a point:

- Overview of the transition to the semester system.
- Explanation to subject expert for the need of syllabus modification and in the content not to use the word "etc" in the syllabus.
- Presentation of feedback from faculty members, students, and relevant stakeholders regarding the current syllabus and their perspectives on necessary changes.
- Emphasis on maintaining academic rigor, ensuring coverage of essential topics, and optimizing student learning outcomes.

Resolution

Formal approval of the proposed changes to the syllabus. Acknowledgment of the efforts put into aligning the curriculum with the semester system. Agreement on a communication plan to inform faculty, students, and other stakeholders about the approved modifications. Ensuring clarity on the reasons for the changes and the benefits to students. Discussion on any additional resources required for the successful implementation of the modified syllabus. Allocation of necessary resources to support faculty and students during the transition.

For ongoing syllabus

- Brief presentation on the status of ongoing syllabus modifications, highlighting completed revisions and those still in progress.
- Discussion on adherence to the established timeline and any deviations.

Resolution:

- Board acknowledges the progress made in ongoing syllabus modifications.
- Confirmation of alignment with the set objectives and a commitment to maintaining the momentum.
- Authorization to make necessary adjustments to the timeline if deemed beneficial for the quality of modifications.
 - As Physiotherapy is an Annual Course, there must be a Supplementary Examination inbetween the year (preferably after 6 months), to give students a chance to clear their

Backlog Subjects as it happens in most of the universities having annual curriculum.
 So, that there must not be an Extra Burden on students during Final Exams to clear both
 Regular as well as Backlog Subjects together.

Minutes of Meeting

- The handbook for physiotherapy rules and regulation to be applied in Syllabus and Starts the Semester Wise System in BPT and MPT courses.

- Fundamentals of health care delivery system will be incorporated only in semester I.
- Biochemistry subject will be incorporated only in semester II.
- Logbook should be introduced for clinical postings for BPT 3rd year, Final year and MPTs.
- Priority should be given more to Physiotherapeutic subjects while allocating credit hours
- For BPT First year the Dissection demonstration on cadavers should be implemented in collaboration with other medical universities.

- The credit allotment for non-university courses should be in reference to the existing university norms.
- For non-university subject grading should be incorporated on the marksheet.

For Semester Wise Scheme:

S. No	Suggested changes
1.	For BPT 1 st year Biochemistry should be only in 2 nd semester.
2.	One Elective subjects should be added in each semester
3.	Parents teacher meeting should be promoted and the response to be documented
4	Arrange Alumni talk in every semester
5	For value added courses workshops should be arranged.

For Current Syllabus

- Logbook should be Implemented for second, third and fourth year.
- Industrial Visits should be held twice a year for all the Batches.
